<p>28 Razom Emergency Response. We restarted our Emergency Response work to address shortages in supplies and information about COVID-19 in Ukraine and in New York. Once the second wave hit Ukraine in the winter and spring of 2021, Razom helped by funding the purchase of 32 oxygen concentrators through local organizations in eight different regions of Ukraine. This essential equipment helped Covid-19 patients as they waited for hospital admittance or when they were discharged to convalesce at home. <p>29 Razom Culture. Razom co-hosted the second annual Ukrainian Contemporary Music Festival in New York City in March 2021. The aim of the festival, which is open to the public and held in English, is to showcase Ukraine's complex and unique contributions to contemporary music through musical performances and discussions with music scholars, performers, and composers. At the end of 2021, Razom supported the first Ukrainian movie to ever be selected for the World Cinema Dramatic Competition at the Sundance Film Festival. Writer and director Maryna Er Gorbach's movie, "Klondike," tells the story of a family living in the war zone in eastern Ukraine at the time that Malaysia Airlines Flight 17 (MH17) was shot down. Razom provided funds for the team's travel to the U.S. to attend the festival. Due to the surge of the Covid-19 Omicron variant in January, the Sundance Festival went all virtual. Razom reallocated the funds from travel to promoting the participation of the filmmakers in the online festival. The Razom Book Club is a group of engaged readers who read Ukrainian literature and works about Ukraine and support Ukrainian authors. In 2021, the club had an active year meeting monthly and sometimes even more. In 2021, the club read 13 books and was able to meet with the authors of five of those books including Volodymyr Rafeyenko, Vasyl Makhno, Artem Chapay, Olena Stiazhkina, and Oleksiy Nikitin. Club members loved Volodymyr Rafeyenko's book "Mondegreen: Songs about Death and Love" so much that they partnered with The Ukrainian Research Institute at Harvard University (HURI) publications' arm to raise money for the book's translation into English.
